Chairman Francis announced the Public Hearing for 2010-2011 Local Budgets will be held Thursday, April 22, 2010 at 7:00 p.m. at the Education Center. Special Olympics will be held Friday, May 7th at 9:00 a.m. at the Waynesville Recreation Park – rain date is scheduled for May 10th. The next regular Board meeting will be held Monday, May 10th at 7:00 p.m. at the Education Center.

Walt Leatherwood remarked that the Tuscola and Pisgah Country Western shows were outstanding. Mr. Leatherwood stated we have great kids in our school system and thanked those individuals that made these two shows successful.
