At their January 11, 2010 regular meeting, the Haywood County Board of Education took the following action:

Vice Chairman Woody called the meeting to order at 7:00 p.m.

Mr. Rogers gave the invocation and led in the Pledge of Allegiance.

Vice Chairman Woody announced Chairman Francis was out of town on business. Vice Chairman Woody said the Board was happy to have Mr. Wyatt present. Mr. Wyatt expressed his thanks for all of the cards, prayers and well wishes.

Vice Chairman Woody recognized Steve Brown who announced the upcoming Mardi Gras fundraising event to be held February 6, 2010 at the Gateway Club sponsored by OldTown Bank.
