SCHOOL BOARD NEWS

At their March 9, 2009 regular meeting, the Haywood County Board of Education took the following action:

Jimmy Rogers gave the invocation and led in the Pledge of Allegiance.

Chairman Francis announced upcoming Board meetings and events.

Chairman Francis recognized Dr. Garrett who read the following statement:

Late this afternoon we were notified that Haywood County Schools and other local agencies will experience significant and immediate local budget cuts. This is in addition to the budget reversions experienced earlier this school year. The new budget cut for Haywood County Schools is approximately 7% or \$1,010,628.

It will obviously take some time to work through an unexpected budget reversion of this magnitude. Effectively immediately, all local non-personnel expenditures are frozen. The Central Office will not process new Purchase Orders or other expenditures from local budget lines.

This information was shared with School Board Members earlier this evening. School administrators will begin reviewing the local budget immediately to determine specific budget line items for these required reversions. An emergency meeting of the Board Finance Committee is being scheduled.

We do not have additional information at this time. However, we will share additional information as it becomes available.

Chairman Francis read the North Carolina School Board Association's official statement on the diversion of funds by Governor Beverly Perdue, February 2009.

NCSBA recognizes that it is the Governor's constitutional responsibility to balance the State budget. NCSBA further recognizes that school districts have lost, percentage wise, less than the University system, community college system, other departments of state government, and other functions funded by the State. While the State's contribution to school construction is very important, NCSBA believes that given the current economic conditions, that the transfer and elimination of the quarterly payment of lottery funds and corporate income tax collections for school construction, and the transfer of the funds from the Public School Building Capital Fund, lottery reserve and textbook fund, was the lesser of other bad options. However, NCSBA opposes any further transfers or elimination of future payments for school construction.

Chairman Francis extended the Board's sympathies to Dr. Garrett who suffered the loss of her stepfather and mother, Ellis and Rebecca Parker, within twenty four hours of each other in mid-February. Chairman Francis stated memorials can be made to the Haywood County Schools Needy Children's Fund on their behalf.

Approved February 9, 2009 regular and closed session minutes

Approved the following Board policies: A-05 Attendance, Membership & Course Credit; A-28 Video Cameras on Buses; SA-08 Athletics and Extra Curricular Activities.

Tabled the following policies until the next regular meeting to allow for public input: A-14 Nonresident students; P-28 Reduction in Force – Classified Personnel

Approved the two-year Accreditation Progress Report as presented by Dr. Bill Nolte. Mr. Wyatt commended Dr. Nolte on a job well done. Dr. Nolte stated several individuals including the Curriculum and Instruction staff along with principals had been involved in producing the report.

Appointed Jimmy Rogers to serve on the NCSBA Legislative Committee.

Approved the revised Resolution for Funding Formula as presented by Larry Smith.

Approved Dixon Hughes be awarded the 2008-09 audit bid.

Approved regular monthly financial reports and budget revisions and amendments.

Michael Sorrells, Chairman of the Finance Committee, made the following statements:

Local Budget

The Finance Committee will meet at 7:00 p.m. Tuesday, March 17th after the Board Retreat to review the FY 2009-2010 Local Budget.

Received budget assumptions on Thursday, March 5th from DPI: Employer Portion Hospital Insurance – Estimate of 7.29% Increase Employer Portion Retirement – Estimate of 4.91% Increase

FY 2009-2010 Local Budget will be presented to the School Board at the April 6th Board Meeting.

A Public Hearing on the 2009-2010 Local Budget will be held Thursday, April 23rd at 7:00 p.m. here at the Education Center.

State Budget:

Weekly Conference calls are being held each Friday at 11:00 a.m. to update Superintendents

The Governor's office has set up a Stabilization office to address the Federal Stimulus Funds North Carolina expects to receive

The big question is how much money will LEAs receive in FY 2009-2010 to offset State Budget Reductions

We hope to have more information when the Governors budget is submitted later in March.

FY 2008-2009 State Budget:

We received information on Tuesday, February 24th that we could expect another State reversion of ½ to 1% which would be between \$209,000 and \$418,000.

However on Wednesday, February 25th we received an email from DPI that the latest quarterly distribution for lottery capital funds and ADM capital funds will be redirected to help address the budget shortfall instead of a second reversion.
