*At their September 14, 2009 regular meeting, the Haywood County Board of Education took the following action:*

Tim Lolley gave the invocation and led in the Pledge of Allegiance.

Chairman Francis announced several Board members were absent due to various reasons.

Chairman Francis thanked Dr. Garrett and Dr. Nolte for a smooth start to the school year.

Chairman Francis talked about the Volunteer Workday held August 8th, stating he was overwhelmed by the support the faith based community has given to our school system.

The Board recognized churches, community organizations, and a private academy that participated in the Day of Service.

Nick Honerkamp and Steve Brown with HCS Foundation presented a check for \$47,000 to Chairman Francis and Dr. Garrett – money raised through the Save-A-Teacher campaign.
