# SCHOOL BOARD NEWS

The Haywood County Board of Education met in a regular session Monday, March 14, 2011 at 7:00 p.m. and took the following action:

Chairman Francis called the meeting to order at 7:00 p.m.

Larry Harbin gave the invocation and led in the Pledge of Allegiance.

Chairman Francis announced the next regular Board meeting is scheduled for Monday, April 11, 2011. Chairman Francis shared a thank you letter from Brian Briggs regarding his appointment to the Haywood Community College Board of Trustees.

Chairman Francis congratulated the Haywood County Schools Foundation for a successful Mardi Gras fundraising event.

Recognized Haywood Middle Academy Students for their work regarding water pollution. Students Chris Ware and Nathan Jones were present to address the Board regarding their research project.

Beverly Elliott addressed the Board regarding a letter concerning Senate Bill 8 that was sent home with students by a school principal. Mrs. Elliott inquired whether or not school resources were used and expressed her concern over students being used as a vehicle for distribution of this type of information.

Norman Medford addressed the Board regarding a letter he had received in his son's backpack regarding Senate Bill 8. Mr. Medford stated the letter had been prepared by and distributed to students by school officials. Mr. Medford asked whether or not the Board and/or the Superintendent had knowledge of the letter and its distribution. He also shared other concerns about a school.

Kristie Norton addressed the Board regarding concerns she has about a school.

James Robertson addressed the Board to express his concern about receiving the letter regarding Senate Bill 8, stating he feels it is inappropriate to send a letter of this nature home with children. Mr. Robertson stated he feels there is a general frustration with the way things are being conducted with the school in question and asked the Board to look at how things are being conducted.

Bruce Gardner addressed the Board regarding a principal taking two days in March to address the North Carolina Senate for a total of four minutes regarding Senate Bill 8. Mr. Gardner inquired whether or not the principal was on school time or took personal leave.

Approved February 14, 2011 closed and regular session minutes and March 7, 2011 called session minutes.

Heard an update from Knox Hardin on change in graduation dates. Pisgah High School's graduation ceremonies will be conducted on Tuesday, June 14<sup>th</sup> at 7:00 p.m. at the WCU Ramsey Center and Tuscola High School's graduation ceremonies will be conducted on Wednesday, June 15<sup>th</sup> at 7:00 p.m. at the WCU Ramsey Center. There was no change for Central Haywood High School's graduation ceremony – it remains on Monday, June 13<sup>th</sup> at 6:00 p.m. at Haywood Community College.

Approved a resolution regarding SB8.

Heard revised policy C-04 Report Cards, Progress Reports and Student Assessments for information only. The policy was tabled until the next regular meeting to allow for public input.

Approved regular monthly financial reports.

Approved allowing the Haywood County Schools' Foundation to begin immediately paying for Foundation Director Steve Brown's travel expense at a \$1500.00 annual savings to Haywood County Schools.
