

SCHOOL BOARD NEWS

The Haywood County Board of Education met in a regular session Monday, August 11, 2014 at 7:00 p.m. and took the following action:

Chairman Francis called the meeting to order and Mr. Rogers gave the invocation and led in the Pledge of Allegiance to the Flag.
