Approved the 2017-2018 Haywood County Schools Calendar as presented by Ron Moss – Mr. Jim Francis, Chairman Francis, and Mr. Jimmy Rogers thanked the Calendar Committee for their hard work. Mr. Rogers shared in hopes that Legislature will give the Board more calendar flexibility in the future.

Approved the resolution in opposition of House Bill 265 as presented by Chairman Chuck Francis

Approved the revised 2017 Summer School Plan as presented by Teresa Cook

Special Issues Committee met March 13, 2017 to discuss a Folkmoot request. No action was taken. Chairman Francis stated that he sought legal counsel on the request about the possibility of using another avenue to have this approved. This request will not be approved.

Approved the following policies

Monthly financial reports were not available due to April board meeting being held early in the month. Financial reports will be submitted for board approval at the May 8, 2017 meeting.

Approved a \$.10 increase in student lunch prices for the 2017-2018 school year as presented by Finance Committee. New prices will be Pre-K-5 \$2.55 and grade 6-12 \$2.80. Breakfast prices will remain the same at \$1.25

On behalf of Building and Grounds Committee, Mr. Jimmy Rogers stated the Committee will be conducting further analysis as to the future of Central Elementary School. A decision will be forthcoming.

Approved the bid for Tuscola and Pisgah High School gymnasium air condition and water heater replacement as presented by Building and Grounds Committee. The bid is awarded to Johnson Controls with a base bid price of \$696,649.00 with an alternate of E1(new power panels) at \$12,097.00 upgrading to Trane equipment for \$23,500.00 for a total cost of \$732,246.00

Approved Building and Grounds Committee recommendation to use up to \$22,000 for the best drill pad for Tuscola AFJROTC constructed at the best price.

Pending Attorney Smathers approval of contract, the Board approved the Building and Grounds Committee recommendation to allow Pisgah High School to purchase and mount a new scoreboard at the football field. The initial cost of the scoreboard is an estimated \$43,287.00. Pisgah High School has been in negotiations with Pepsi Corporation and they have agreed to fund \$20,000.00 of the project in return for Pisgah placing a permanent advertisement on the scoreboard. The remaining four advertisement spaces will be sold bringing the remaining balance to approximately \$7,287.00. The Pisgah High Athletic Boosters have agreed to fund the remainder of the balance.
