Board Attorney Pat Smathers addressed the Board to officially notify them that the Open Meetings Law may have inadvertently been violated at the last meeting on January 9, 2018. The meeting was scheduled for January 8, 2018 and at the last minute was cancelled due to inclement weather. In good faith, the meeting was rescheduled for the following day. Unfortunately, this may not have been correct as to the technical reading of the Open Meetings Law. As with any statute, there has been no formal decision on this kind of situation. Attorney Smathers feels it's the better practice to reaffirm and accept all action that was taken at the January 9th meeting. When the meeting was cancelled on January 8th, it was announced that the meeting would be held the following day. It was publicized and notification went out to the Press and all parties but there still may have been a technical violation of the Open Meetings Law. Attorney Smathers prepared a motion to reaffirm all action from the January 9, 2018. His job is to identify issues and come up with solutions.

Approved the motion to accept, ratify, and reaffirm all decisions and actions taken by the Board at the January 9, 2018 meeting which began at 12:31 p.m. and adjourned at 1:18 p.m. The meeting held on January 9, 2018 being a rescheduled meeting for the January 8, 2018 meeting which was cancelled due to inclement weather.

Approved the motion for the Town of Waynesville to remove four maple trees along Camelot Drive at Waynesville Middle School baseball field due to the root system damaging sidewalks; presented by Building and Grounds Committee. Town of Waynesville will absorb all cost and there will be no cost to Haywood County Schools.

Approved the motion for Company Roof Options to replace the Canton Middle School Cafeteria roof with a standing metal seam roof with a bid of \$67,401 pending reference check on the vendor; presented by Building and Grounds Committee.

Approved the motion to use ADM Funds to place Access Control at Central Haywood High School for a cost of \$55,000.00 as presented by Building and Grounds Committee.

Approved the motion to use local funds to pay a teacher performance bonus to one employee whose EVAAS scores were in the top 25% for both the State and LEA level. Per legislation, employee was ineligible to be paid the bonus using state funds due to an employment status change in August. Total cost to local for the bonus will be \$4,628.95; presented by Finance Committee

Approved the motion to purchase cyber liability insurance at an estimated cost of \$2500 for the remainder of 2017-20188 and approximately \$5500.00 for 2018-2019 as presented by Finance Committee.

Approved the regular monthly finance reports as presented by Finance Committee.

Approve the amendment to the calendar weather plan as presented by Jenny Wood-Valliere.
