FINAL PUBLIC NOTICE

Haywood County Schools has applied for Federal Emergency Management Agency (FEMA) Public Assistance (PA) Program funding through the North Carolina Emergency Management (NCEM) as a sub-recipient.

Under the National Environmental Policy Act (NEPA), federal actions must be reviewed and evaluated for feasible alternatives and for social, economic, historic, environmental, legal, and safety considerations. Under Executive Order (EO) 11988 and EO 11990, FEMA is required to consider alternatives, and to provide a public notice of any proposed actions in or affecting floodplains or wetlands. EO 12898 also requires FEMA to provide the opportunity for public participation in the planning process and to consider potential impacts to minority and low-income populations. This notice may also fulfill requirements under Section 106 of the National Historic Preservation Act (NHPA).

Funding for this project will be conditional upon compliance with all applicable federal, tribal, state, and local laws, regulations, floodplain standards, permit requirements and conditions.

Special Flood Hazard Area Zone:

This project is for proposed repairs to the Pisgah High School Baseball Field in Haywood County, which is in the AE (1% Chance Annual Flood Risk) flood zone. Confirmation of location in a Special Flood Hazard Area (SFHA) was determined by the Buncombe County Effective Flood Insurance Rate Map, Panel Number: #3700865600J, dated 04/03/2012. The proposed work conforms to all applicable State of North Carolina and local floodplain regulations. The work has the potential to be impacted by flooding events due to its location in the floodplain. The proposed work will not take place in a wetland per the United States Fish and Wildlife Service National Wetlands Inventory and will have no potential to impact or affect wetland values.

Proposed Work and Purpose:

Haywood County Schools proposes to make repairs to the Pisgah High School Baseball Field, including removal and replacement of baseball field electrical utilities, recreational construction materials (concession stand, restrooms, and dugout building components), infield and outfield sod and athletic conditioner, dugout brick paver walkway, fencing, lighting elements, crushed gravel along warning track, as well as removal of excess silt/sediment within the baseball field. Mitigation measures consist of elevating electrical panel boards and outlets, as well as upgrading building materials. The purpose of this project is to repair the baseball field elements and provide continued open space use and recreational space for the community.

Project Alternatives:

Alternative #1: (No action alternative): The 'no action' alternative would ultimately result in a negative impact on the community as the baseball field serves as open-space use and recreational space.

Alternative #2: (Relocation): Relocation is not economically practicable. The baseball field also facilitates open-space use and recreation for the community. If the baseball field was moved, adverse economic and social impacts may occur.
